

# Colorado Ranger Horse Association Halter & Performance Futurity

## GENERAL PROVISIONS:

The CRHA Halter & Performance Futurities will be held in conjunction with the CRHA National Show. To be eligible, the owner and exhibitor of a nominated horse must be a current CRHA member(s) in good standing. Any owner may nominate as many entries as desired. Ownership of futurity entry does not affect eligibility if the new owner is a CRHA member in good standing and the transfer is reported to the CRHA Executive Secretary and Futurity Chairperson, and the futurity nomination transfer fee of \$5.00 is paid at the time of the transfer.

It is the owner's responsibility to remit payments on time and to be acquainted with all rules and provisions. All checks or money orders should be made payable to CRHA, have Futurity written on the memo line, and mailed to the Futurity Chairperson. Returned checks will be charged to appropriate rate in accordance with the CRHA rules.

**\*All Futurity entries must be CRHA registered, entered and shown in corresponding CRHA National Classes.** Example: **Weanling Filly** must also be entered in Current Year Halter Fillies at Nationals. Futurity and CRHA classes will run concurrently, but only paid futurity nominees will be placed in the futurity divisions.

## Futurity Divisions:

**Weanling Halter Division:** There will be three (3) classes offered-Weanling Stallion (F1), Weanling Mares (F3), and Weanling Geldings (F5). Classes will run concurrently with appropriate sex division classes.

**Yearling Halter Division:** There will be Three (3) classes offered- Yearling Stallion (F2), Yearling Mares (F4), and Weanling Geldings (F6). Classes will run concurrently with appropriate sex division classes.

**Yearling Lungeline Division:** There will be one (1) class offered (F7) to run concurrently with the CRHA Lungeline class, #27.

**2 & 3 Year Old Walk/Trot/Jog Division:** There will be one (1) class offered (F8) to run concurrently with the CRHA 2 & 3 YO Walk/Trot Pleasure class, #44.

## Colorado Ranger Horse Association Futurity Rules:

1. Futurity classes are governed by CRHA show rules.
2. Postmark designates official date entered.
3. Lunge line: Exhibitor may show multiple horses but must have additional handler for the conformation portion of the class.
4. Score sheets will be posted as soon as possible after class is completed.
5. Notification of death of horse entered, received and documented by September 5<sup>th</sup> of the current year will have ½ of fees paid refunded.
6. Any discrepancies/infractions must be brought to the attention of the futurity Chairperson before the end of the show.
7. Decisions of the judge are final. If felt not satisfactory, an official protest must be submitted. See the CRHA Rules regarding an official protest.

## **Futurity Rules continued.....**

8. Prize money (checks) not cashed before 90 days after it is received, it will be considered a voided check.

**Any rules herewith can be changed, added to, or denied at the discretion of the Futurity Chairperson. The CRHA Board of Directors will have the final word in interpreting or supplementing the rules and conditions of the Futurity if the need arises.**

### **AWARDS:**

80% OF THE ENTRY FEES ACCURE TO THE PURSE OF THE CLASS INVOLVED. Added monies from sponsors will be divided between all classes. Ribbons and purse money will be awarded through 5<sup>th</sup> place.

- F8:** 2 & 3 Year Old Walk/Trot/Jog Pleasure (to run concurrently with CRHA National class 44)
